

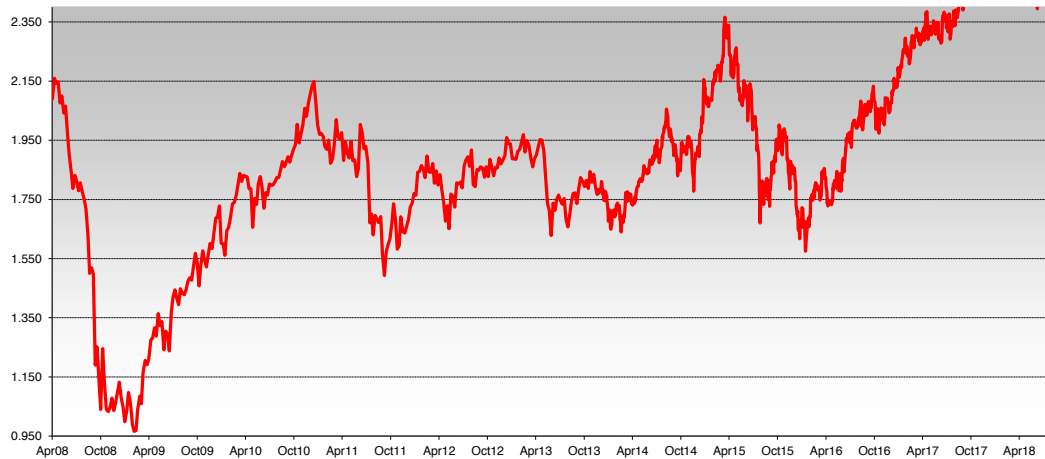
(23) HLM Emerging Markets Equity Fund
