

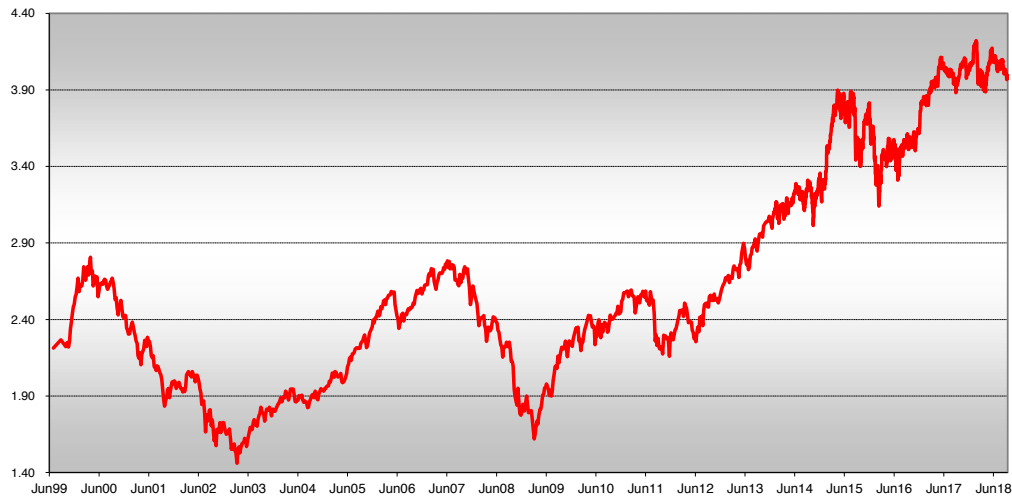
(04) HLM Aggressive Fund

Investment Objective

The Fund aims to produce a steady return expressed in euro, by adopting an aggressive investment strategy. The Fund invests in the other HLM Funds available on HSBC Life Assurance (Malta) Ltd. unit-linked platform to gain access primarily to bond and equity markets. These HLM Funds and their respective underlying funds may invest in financial derivatives, other financial instruments and take out borrowings which may result in the overall risk exposure of the third party funds to exceed their total net asset. For operational purposes the HLM Funds may hold a proportionately small amount of its holdings in cash.
