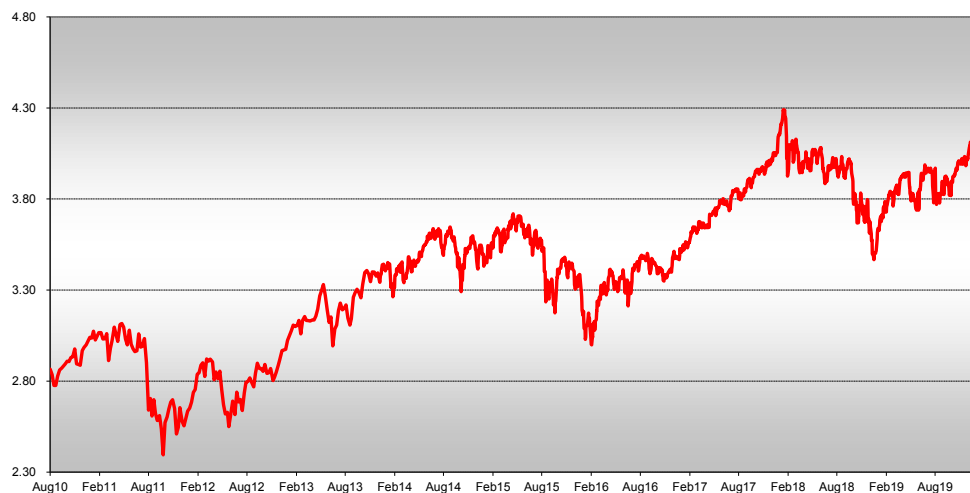


Investment Objective

The Fund seeks to achieve long-term total return expressed in euro by investing in a broad range of asset classes across global markets, consistent with a high risk investment strategy through investment in an underlying fund or funds. The underlying fund may invest in financial derivatives, other financial instruments and engage in leverage which may result in the overall risk exposure of the underlying fund to exceed their total net assets. For operational purposes the HLM Fund may hold a proportionately small amount of its holdings in cash.
