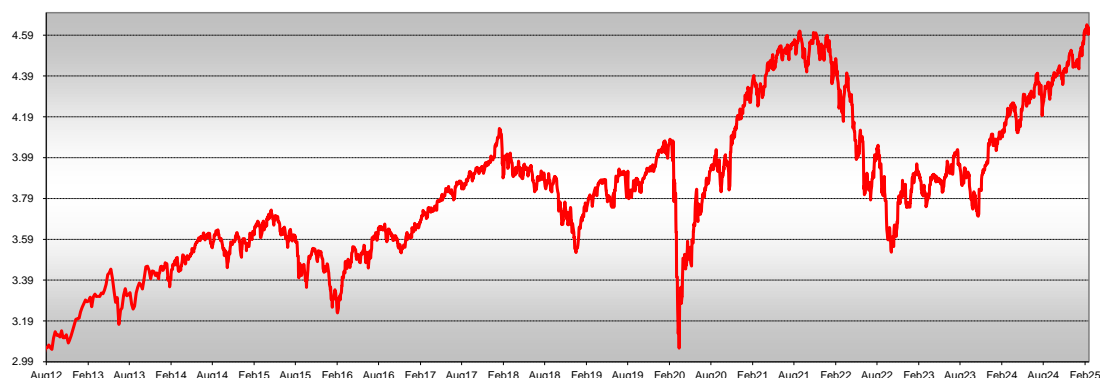

### Investment Objectives

### Performance History in EUR (Bid Price)



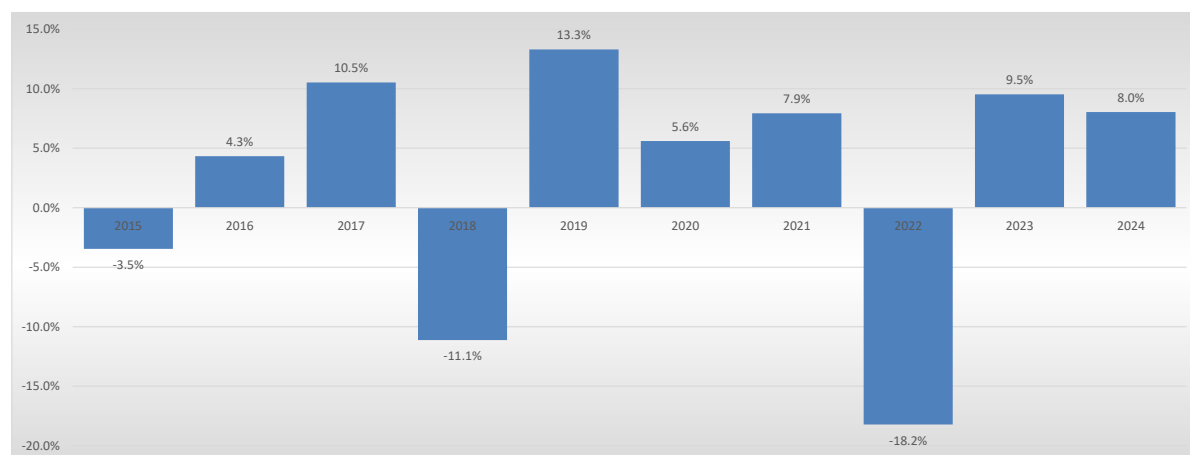
