What is this investment?

Type

Unit Linked - Multi-Option Product

Intended retail investor

This fund is aimed at retail investors who have been able to identify their own risk tolerance, established through the services of a financial adviser and/or a risk tolerance questionnaire, and who can understand the range of potential returns, in the different scenarios indicated in this KID, which this fund may experience, while also acknowledging that these potential returns are in no way guaranteed. The fund is not appropriate for investors who are seeking guaranteed returns or no loss of capital over any time period.

Objective

The Fund seeks to provide long-term capital growth expressed in euro by investing in international equity markets through investment in an underlying fund or funds which may be denominated in other currencies than the euro. The underlying fund may invest in financial derivatives, other financial instruments and engage in leverage which may result in the overall risk exposure of the underlying fund to exceed their total net assets. For the full investment objectives, investment policy and risk factors of the underlying fund please consult the current prospectus. For operational purposes the HLM Fund may hold a proportionately small amount of its holdings in cash.

What are the risks and what could I get in return?

The risk indicator assumes that you keep the investment for 10 years.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.
