The Fund seeks to provide long-term capital growth expressed in euro by investing in international equity markets through investment in an underlying fund or funds which may be denominated in other currencies than the euro. The underlying fund may invest in financial derivatives, other financial instruments and engage in leverage which may result in the overall risk exposure of the underlying fund to exceed their total net assets. For operational purposes the HLM Fund may hold a proportionately small amount of its holdings in cash.

The summary risk indicator is a guide to the level of risk of this investment compared to other investments. It shows how likely it is that this investment will lose money because of movements in the markets or because HSBC Life Assurance (Malta) Ltd. is not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

However, you may benefit from a consumer protection scheme (see the section "What happens if HSBC Life Assurance (Malta) Ltd. is unable to pay out?") within the product KID. The indicator shown above does not consider this protection.
